Privacy Policy – CPAC Hungary 2023

The website www.cpachungary.com (hereinafter: website) is owned by Jogállam és Igazság Nonprofit Korlátolt Felelősségű Társaság (registered office: 1121 Budapest, Budakeszi út 36/C.; company registration number: 24375223-2-43; hereinafter: JIN Kft.) and operated by Art Supreme Korlátolt Felelősségű Társaság (registered office: 1085 Budapest, Rökk Szilárd utca 11. IV. em. 26.; company registration number: 01-09-353968; hereinafter: Company) on behalf of JIN Kft.

The purpose of this website is to provide the necessary registration facilities to the event "CPAC Hungary" to be held in Budapest from the 3th to the 5th of May 2023 organized by the American Conservative Union Foundation (registered office: 1199 N Fairfax St, Suite 500, Alexandria, VA 22314, USA; phone: +1 (202) 347-9388; e-mail: contact@conservative.org, in Hungarian: Amerikai Konzervatív Unió Alapítvány) and the JIN Kft. as the holder of the Center for Fundamental Rights (Alapjogokért Központ) European trademark, to inform interested parties of important information about the event. The website collects and records certain personal data exclusively during the usage of the registration interface. No personal data is required in the course of using other interfaces of the website.

1. Acceptance of the Privacy Policy

- **1.1.** By applying to participate in the event through the registration interface available on the website, you acknowledge and agree to the terms and conditions of the data management information set out by JIN Kft.
- **1.2.** In case you do not agree with the any of terms set out in the Privacy Policy, you are not entitled to use the registration interface of the website.

2. Data Controller

- **2.1.** Your personal data is processed by Jogállam és Igazság Nonprofit Kft. (hereinafter: Data Controller), the Data Controller is responsible for the legality of data processing under Hungarian and European Union law [Act CXII of 2011 on the right of informational self-determination and the freedom of information (hereinafter: Information Act.; Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation)].

3. Legal basis of data processing

The legal basis for the processing of your personal data in accordance with Article 6(1)(a) of the GDPR is your explicit consent, which you provide to the Data Controller by registering for the "CPAC Hungary" event.

4. Purpose of data processing

The purpose of the data processing is maintaining contacts related to the organization process of "CPAC Hungary" as well as providing information on the results of the event.

5. The processed personal data

During the course of the registration process the following personal data are required: first name, last name, date of birth and e-mail address.

6. Data storage period

- a) In case of successful registration (with the possibility to participate in person) the Data Controller will process the personal data provided by you until the 30th day after the "*CPAC Hungary*" event, but no later than 5 June 2023.
- b) In the case of an unsuccessful registration (with no opportunity of personal participation) your personal data will be processed until the commencement of the "CPAC Hungary" event, but no later than 3 May 2023

7. Your rights related to the personal date processed by the Data Controller

7.1. Right of access [GDPR Article 15.]

You have the right to receive feedback from the Data Controller on whether it is processing any of your personal data and, if so, to be informed of the purposes of the processing, the categories of personal data stored, the duration of the storage of the data and your rights in relation to the processing. Under this right, you may request that a copy of the personal data processed be provided to you, however this must not adversely affect the rights of others.

7.2. Right to rectification [GDPR Article 16]

Under the right of rectification, you may request the Data Controller to rectify inaccurate personal data concerning you without undue delay and to complete incomplete personal data, taking into account the purposes of the processing.

7.3. Right to erasure ("right to be forgotten") [GDPR Article 17]

In the event that the Data Controller has unlawfully processed your personal data, you may request the Data Controller to delete the relevant personal data without undue delay. If the processing of your personal data is no longer necessary, the Data Controller shall automatically delete them on the grounds that the purpose of the processing has ceased to exist, at the latest after the expiry of the time limit specified for the processing.

7.4. Right of restriction of processing [GDPR Article 18]

You may ask us to restrict the data processing, if

- a) you argue the accuracy of the data, (in this case, the restriction applies for the period of time necessary to allow the Data Controller to verify the accuracy of the personal data);
- b) data processing is illegal, and you choose to require restriction of the data instead of erasure;
- c) the Data Controller is not required to process your personal data anymore, but you need them to submit, endorse or protect legal demands;

d) you have objected against data processing, in which case the restriction will apply until it is established whether the legitimate grounds of the Data Controller prevail over your legitimate grounds.

7.5. Right to portability [GDPR Article 20]

You have the right to receive the personal data provided to the Data Controller, processed on the basis of your consent, in a structured, commonly used, machine-readable format, and the right to transmit such data to another Data Controller without the Data Controller's hindrance.

7.6. Right to withdrawal of consent [GDPR Article 7]

Under the right to withdraw your consent in relation to the processing of your personal data you may withdraw your consent, which constitutes the legal basis for the processing, at any time. However, the withdrawal of the consent does not affect the lawfulness of the processing prior to the withdrawal. In order to withdraw your consent, please contact the Data Controller at the e-mail address **eventcpachungary.com** provided by you to the Data Controller in point 2 in order to ensure your identity. In case you withdraw your consent the Data Controller shall erase your personal data with no further delay.

8. Information on the recordings

The event is open to the press and will be broadcasted live on the internet. Representatives of the press will be present at the event and will make audio and video recordings.

Legal provisions applicable to audio and visual recordings, such as Act V of 2013 on the Civil Code, § 2:48 (1) and (2) determines that recording a person's image or voice and using such a recording shall require the consent of the person concerned, except if the recording was made of a crowd or of an appearance in public life. According to judicial practice, a photograph is considered to be a crowd image if it shows a multitude of people, or if the persons depicted are not seen as individuals but as part of the crowd (e.g. a picture of the audience at a performance).

Photographs in which the data subject appears or from which the data subject can be clearly identified shall be considered as personal data. The provisions of this Privacy Policy also apply to photographs that qualify as personal data.

9. Legal remedies

You have the right to contact the Data Controller at any time using the contact details provided in order to exercise your rights in relation to the processing of your personal data. The Data Controller shall take the necessary measures in relation to the requests pursuant to Section 15 (1) (b) of the Information Act without delay, but within 25 days at the latest, and shall inform you thereof. Should you have found the Data Controller's enquiry to be ineffective, or believed that the Data Controller had restricted you in the exercise of your rights, you may initiate an investigation by the Authority by lodging a complaint with the National Authority for Data Protection and Freedom of Information (1055 Budapest, Falk Miksa utca 9-11., tel: +3613911400; email: ugyfelszolgalat@naih.hu). In the event of a breach of the law relating to the processing of personal data, to initiate official proceedings by the Authority and to take legal action.

10. More information on the data processing

10.1. Your personal data will be processed on computer in a secure environment in Hungary and will not be disclosed or transferred them to any third parties.

- **10.2.** Apart from the designated employees of the Data Controller, the personal data may be accessed by the Company entrusted by the Data Controller with the operation of the website and by the designated employees of the Service Provider entrusted with the provision of access to the event, Moonlight Event Szolgáltató Rendezvényszervező Korlátolt Felelősségű Társaság (registered office: 1022 Budapest, Tövis utca 10.; company registration number: 01-09-329216), who have undertaken to maintain confidentiality with regard to the data obtained in connection with the performance of their duties.
- **10.3.** In the course of its processing activities the Data Controller shall take all reasonable steps to ensure that the data it processes are not disclosed to unauthorised persons.
